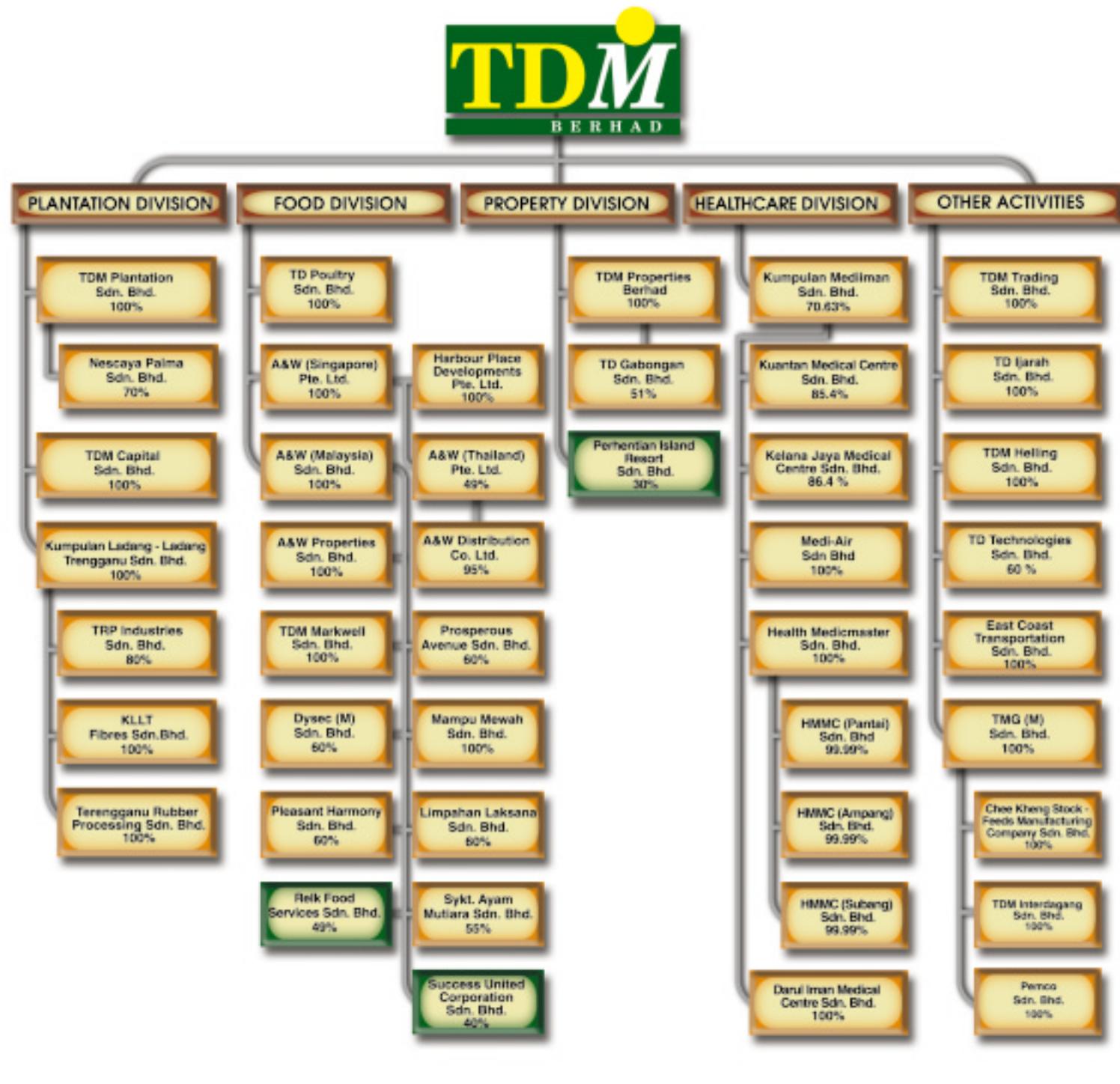

# PENYATA PENGERUSI

## CHAIRMAN'S STATEMENT

Saya, bagi pihak Lembaga Pengarah, dengan sukacitanya membentangkan Laporan Tahunan dan Laporan Kewangan untuk syarikat bagi tempoh berakhir 31 Disember 1999.

Tahun 1999 merupakan suatu tahun untuk merasionalisasi aktiviti perniagaan kumpulan. Aktiviti perniagaan kumpulan telah ditinjau berasaskan objektif mefokus kepada kekuatan kumpulan dan juga untuk meningkatkan keuntungan para pemegang saham.

Bahagian perladangan terus menjanakan keuntungan walaupun harga komoditi pada tahun 1999 adalah jauh lebih rendah berbanding tahun 1998. Bahagian makanan mengalami kerugian dalam tahun 1999 dan tindakan telahpun diambil untuk menstruktur semula dan memperbaiki operasi dalam bahagian ini.

Kumpulan mencatat kerugian sebanyak RM20.5 juta berbanding keuntungan sebanyak RM27.8 juta di dalam tahun 1998. Segala tindakan telah diambil bagi memastikan kumpulan memperolehi keuntungan di dalam tahun 2000.

### TINJUAN OPERASI

#### Bahagian Perladangan

Bahagian Perladangan terus mencatat keuntungan dalam tahun 1999 meskipun harga komiditi rendah. Peningkatan dalam hasil FFB dan pengurangan kos pengeluaran membantu mengurangkan kesan daripada penurunan harga CPO/PK.

Tahun 2000 akan menyaksikan lebih banyak kawasan mencapai kematangan dan peningkatan dalam hasil FFB. Dalam tahun 1999, syarikat juga telah memulakan operasi di sebuah ladang kelapa sawit berukuran 4,100 hektar di Sibu, Sarawak. Projek ini dijangka menyumbang secara positif terhadap keuntungan syarikat dalam 4 – 5 tahun yang akan datang.

Bahagian Perladangan mencatat keuntungan sebanyak RM12.9 juta dalam 1999 berbanding RM27.2 juta dalam 1998.

Perolehan daripada bahagian perladangan akan terus meningkat dengan pertumbuhan berterusan di kawasan matang dalam 2-3 tahun yang akan datang.

It is with great pleasure that I present to you, on behalf of the Board of Directors, the Annual Report and Financial statements of the company for year ended 31st December 1999.

1999 was a year for rationalisation of the group's business activities. The group business activities were reviewed with the objective of getting focussed on the group strength and to enhance shareholders wealth.

The plantation division continued to record profits even though the commodities prices for 1999 were much lower than 1998. The food division incurred losses in 1999 and measures are initiated to restructure and improve the business operation of this division.

The group recorded a loss of RM20.5 million compared to RM27.8 million profits in 1998. All measures are being initiated to place the group back to profitability with better focus in the year 2000

### REVIEW OPERATION

#### Plantation Division

The Plantation Division continued to record profit in the year 1999 even with lower commodity prices. FFB yield increase and production cost reduction helped offset the sharp decline in CPO / PK price.

Year 2000 will see more area coming into maturity and increase in FFB yields. In the year 1999, the company has also commenced its operations on a 4,100 hectares oil palm plantation in Sibu, Sarawak. This project is expected to contribute positively to the company in the next 4 – 5 years.

The Plantation Division recorded a profit of RM12.9 million in 1999 as compared to RM27.2 million in 1998.

With the continued growth in the mature area in the next 2-3 years the plantation division earnings will continue to show growth.



## *Penyata Pengerusi...samb.*

### *Chairman's Statement....cont'd.*

Usahasama di dalam memajukan perusahaan kelapa sawit dengan Tabung Warisan dan Majlis Agama Islam akan mencapai kematangan secara berperingkat. Ini akan turut menyumbang kepada perolehan dan keuntungan syarikat.

Pemprosesan FFB dalam dua kilang pemprosesan mencatat kadar pertumbuhan yang tinggi. Kedua-dua kilang telah memproses 493,162 tan metrik dalam 1999 berbanding 369,917 tan metrik dalam 1998. Kadar penggunaan yang tinggi meningkatkan perolehan dan keuntungan syarikat. Dengan peningkatan dalam pengeluaran FFB dan lebih banyak kawasan mencapai tahap sedia-dituai, kedua-dua kilang tidak akan berupaya menampung keperluan pemprosesan hasil menjelang tahun 2001. Syarikat telah mengambil tindakan untuk membina satu lagi kilang pemprosesan kelapa sawit di Bukit Besi, Dungun, Terengganu. Kami menjangkakan ianya siap menjelang penghujung tahun 2001. Ini juga akan meningkatkan perolehan dan keuntungan Bahagian Perladangan.

#### **Bahagian Makanan**

Bahagian Makanan memerlukan rasionalisasi yang lebih lanjut dalam tahun 2000 untuk meningkatkan keberkesanan operasinya. Lembaga yang baru telah mengambil tindakan untuk menyatu-padukan operasi dan mengurangkan kos operasi. Kami menjangkakan kemajuan daripada Bahagian Makanan dalam tahun 2000. Pihak pengurusan sedang bertungkus lumus untuk memperbaiki keberkesanan operasi dan perolehan.

Dalam tahun 1999, Bahagian Makanan mengalami kerugian sebanyak RM26.4 juta berbanding RM10.6 juta dalam tahun 1998.

Dengan operasi A&W dalam Kumpulan TDM di tiga buah negara, kumpulan berada dalam kedudukan yang baik untuk memanfaatkan ekonomi skala dan menjadi salah suatu entiti utama dalam industri 'makanan segera' ('fast food') di rantau ini. Lembaga sedang berusaha menjadikan Bahagian makanan antara penyumbang utama terhadap perolehan kumpulan di tahun-tahun yang akan datang.

The Joint Venture on oil palm development with Tabung Warisan and Majlis Agama Islam are coming into maturity in stages. This will also improve our revenue and profitability.

The milling of FFB in our 2 palm oil mills recorded high growth rate. The 2 mills processed 493,162 metric tonnes in 1999 as compared to 369,917 metric tonnes in 1998. The high utilization rate increases our revenue and profitability. With the increase in FFB production and more areas coming into harvesting, our 2 mills will not be able to cope with the volume by year 2001. The company has initiated measures to construct another palm oil mill in Bukit Besi, Dungun, Terengganu. We expect to complete the mill construction by end of year 2001. This will increase our revenue and profitability of the Plantation Division.

#### **Food Division**

The Food Division needs further rationalization in the year 2000 to enhance the operating efficiency. The new Board has taken measures to consolidate its operations and reduce its operating cost. We expect progress from the Food Division in the year 2000. The management team is working with renewed vigour to improve its operating efficiency and turnover.

In 1999, the Food Division incurred a loss of RM26.4 million as compared to RM10.6 million in 1998.

With A&W operations in TDM Group from 3 countries, the group is well positioned to reap the economies of scale and be a major regional player in the fast food industry. The Board is working on making the Food Division as a core contribution to the group in the next few years.

### **Lain-lain Hal**

Lembaga meneruskan tindakan untuk merasionalisasikan operasi dalam unit perniagaan lain seperti perkhidmatan perubatan swasta, hartanah dan teknologi maklumat. Unit-unit perniagaan ini akan mempergiatkan usaha untuk menjana pulangan daripada pelaburan yang telah dilakukan oleh kumpulan. Lembaga akan sentiasa menjalankan pemantauan intensif ke atas segala kemajuan dan melaksanakan keputusan perniagaan yang sesuai demi menjaga kepentingan para pemegang saham.

### **PANDANGAN TERHADAP TAHUN 2000**

Dua perniagaan utama kumpulan – Perladangan dan Bahagian Makanan dijangka mengembangkan perolehan untuk kumpulan.

Bahagian Perladangan akan terus mencapai kemajuan dalam pengeluaran dan keberkesanan kos. Walaupun harga CPO menurun hingga ke RM1,100 – RM1,250 per tan, margin operasi masih sesuai pada tahap ini. Bahagian-bahagian ini akan kekal sebagai penyumbang utama kepada keuntungan bagi kumpulan.

Bahagian Makanan juga dijangka mengalami pertumbuhan dengan adanya peningkatan ekonomi dan kembalinya keyakinan dari pihak pengguna. Operasi di Malaysia, Thailand dan Singapura dijangka meningkatkan lagi perolehan dan keberkesanan operasi dalam tahun 2000.

Secara keseluruhannya, tahun 2000 dijangka mencatat kemajuan berbanding tahun 1999.

### **AKTIVITI KORPORAT**

Program ESOS telahpun berjaya dilaksanakan dengan kebenaran daripada pihak berkuasa yang berkenaan dan para pemegang saham.

### **Other Business**

The Board continues in its measures to rationalize the operation of its other business unit such as private medical care, property and information technology. These businesses will be strengthened to recoup the investment by the group on these units. The Board will continue to intensively monitor the progress and make appropriate business decisions in the best interest of the shareholders.

### **OUTLOOK FOR YEAR 2000**

The 2-core business of the group – Plantation and the Food Division are expected to expand its revenue to the group.

The Plantation Division will see continued improvement in the production and cost efficiency. Though the CPO price is lowering at only RM1,100 – RM1,250 per tonne, the operating margins are comfortable at these levels. These divisions will remain the major profit contributors to the group.

The Food Division is also expected to experience growth with the growth in the economy and the return of consumer confidence. Operation in Malaysia, Thailand and Singapore are expected to enhance its turnover and operating efficiency in the year 2000.

Overall, year 2000 is expected to show improvements to that of year 1999.

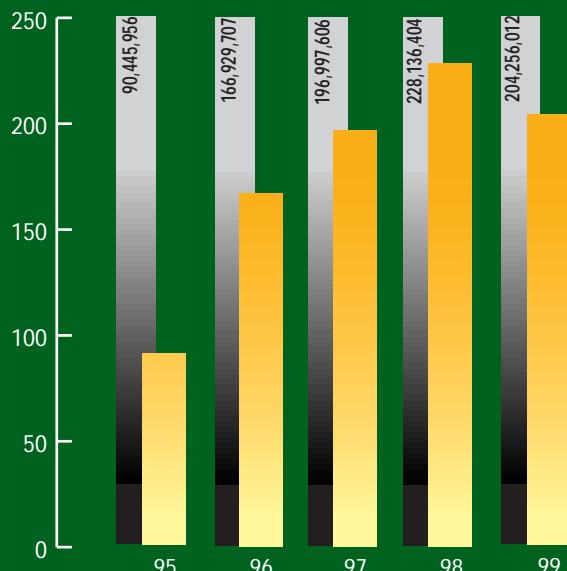

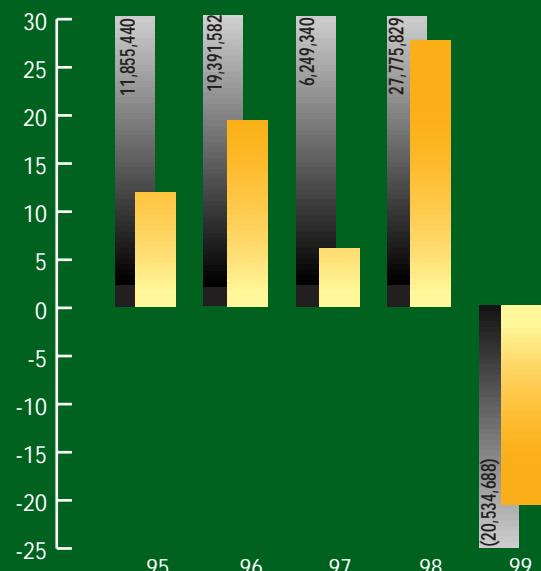

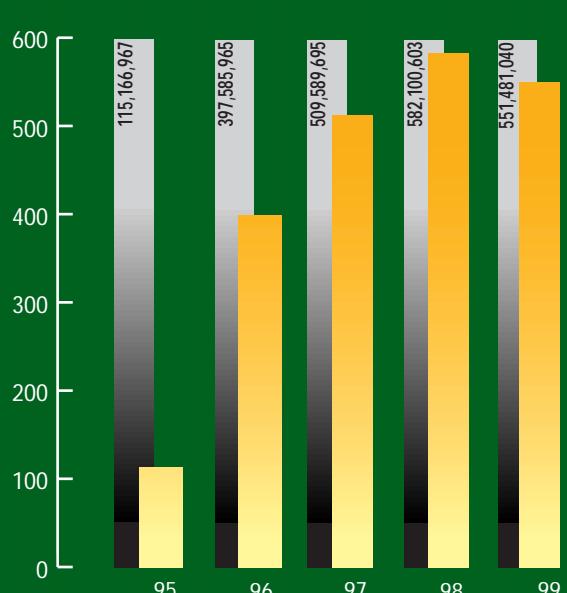

1995 – 1999**



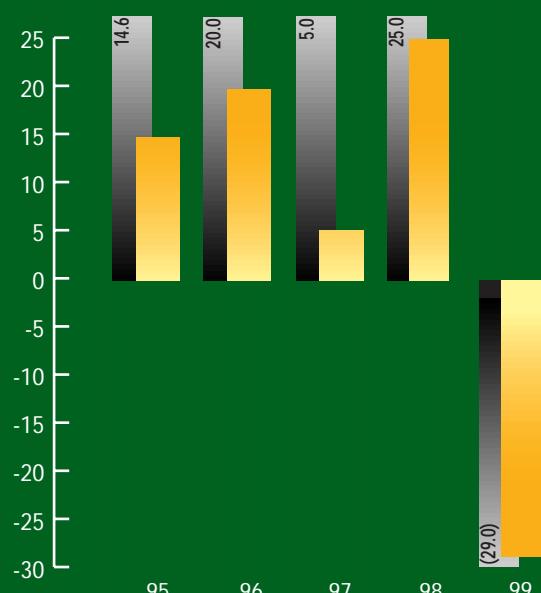
**Keuntungan / (Kerugian)

## BIDANG TUGAS

### Perlembagaan

Ahli Jawatankuasa Audit telah dibentuk oleh Lembaga Pengarah TDM Berhad selaras dengan resolusinya pada 29 Disember 1994.

### Keahlian

Jawatankuasa Audit mestilah dilantik oleh Lembaga Pengarah yang dipilih dari kalangan para pengarah yang terdiri daripada sekurang-kurangnya 3 orang ahli yang majoritinya mestilah tidak terdiri daripada:-

- (a) Pengarah Eksekutif syarikat atau perbadanan yang berkaitan;
- (b) Isteri atau suami, ibu bapa, adik-beradik lelaki, adik beradik perempuan, anak lelaki atau anak angkat lelaki atau anak perempuan atau anak angkat perempuan kepada Pengarah Eksekutif atau perbadanan yang berkaitan; atau
- (c) Sesiapa yang mempunyai pertalian pada pendapat Lembaga Pengarah yang mungkin campurtangan dengan penggunaan pengendalian bebas dalam menjalankan fungsi sebagai Jawatankuasa Audit.

Pengerusi kepada ahli jawatankuasa mestilah dilantik oleh Lembaga Pengarah. Jika seorang ahli daripada jawatankuasa audit meletak jawatan, meninggal dunia atau dengan sebab yang lain berhenti dari menjadi ahli yang mana akibat daripadanya jumlah ahli kurang daripada 3, para Lembaga Pengarah akan dalam jangkamasa 3 bulan daripada kejadian tersebut, melantik beberapa orang ahli baru yang mana diperlukan bagi menjadikan jumlah minima 3 orang ahli.

### Kehadiran Mesyuarat

Korum mestilah terdiri daripada dua orang ahli, salah seorang mesti menjadi Pengerusi Jawatankuasa Audit. Sekurang-kurangnya setahun sekali Jawatankuasa Audit mesti berjumpa dengan Juruaudit luar tanpa dihadiri oleh ahli Lembaga eksekutif. Juruaudit luar berhak hadir pada mana-mana mesyuarat Jawatankuasa Audit.

Setiausaha syarikat akan menjadi setiausaha kepada Jawatankuasa Audit. Minit-minit mesyuarat hendaklah dicatitkan ke dalam buku yang disediakan.

### Kekerapan Mesyuarat

Mesyuarat hendaklah diadakan tidak kurang dari 2 kali setahun. Juruaudit luar boleh meminta mesyuarat diadakan jika mereka memikirkan mesyuarat perlu diadakan di atas sebab-sebab tertentu. Pengerusi Jawatankuasa Audit pasti memanggil mesyuarat Ahli Jawatankuasa bagi menimbangkan sebarang perkara yang pada pendapat Juruaudit luar perlu di kemukakan kepada para pengarah atau pemegang saham.



## *Jawatankuasa Audit...samb.*

### **Kuasa**

Jawatankuasa Audit diberi kuasa oleh Lembaga Pengarah untuk menyiasat sebarang kegiatan yang merangkumi asas-asas rujukannya. Ia diberi kuasa untuk mendapatkan sebarang maklumat yang diperlukan dari sebarang kakitangan dan semua kakitangan yang diarahkan untuk memberi kerjasama terhadap sebarang permintaan oleh Jawatankuasa Audit.

Jawatankuasa Audit diberi kuasa oleh Lembaga Pengarah untuk mendapatkan khidmat perundingan luar atau nasihat profesional bebas lain dan membenarkan kehadiran pihak luar yang memiliki pengalaman dan kepakaran dalam perkara yang berkaitan sekiranya difikirkan perlu.

### **TUGAS-TUGAS DAN FUNGSI-FUNGSI**

Bidang tugas Jawatankuasa ini adalah:-

- a) Untuk menimbangkan perlantikan Juruaudit luar, yuran audit dan sebarang pertanyaan terhadap perletakan dan pemecatan jawatan.
- b) Untuk berbincang dengan Juruaudit luar sebelum memulakan jenis dan audit dan memastikan keselarasan sekiranya terdapat lebih daripada sebuah firma audit yang terlibat.
- c) Untuk meneliti dengan Pengurusan dan Juruaudit luar penyata kewangan setengah tahun dan penyata kewangan tahunan sebelum menyerahkan kepada Lembaga Pengarah, terutamanya terhadap perkara-perkara berikut:-
  - sebarang perubahan di dalam dasar-dasar amalan dan perakaunan
  - bidang-bidang yang memerlukan pertimbangan yang wajar
  - perubahan penting hasil dari audit
  - menuruti piawai-piawai perakaunan
  - menuruti kehendak Bursa Saham dan perundangan
- d) Untuk menguruskan laporan semasa dari pihak Pengurusan, Juruaudit luar dan Juruaudit dalam akan menilai kesan di atas pertukaran penting yang berulang kali; dan perkembangan perakaunan atau laporan yang dicadangkan oleh badan-badan perakaunan atau badan-badan lain, atau sebarang perkara penting yang mempunyai hubungan dalam kajian tahunan.
- e) Untuk membincangkan masalah dan cadangan yang timbul dari audit sementara dan akhir, dan sebarang perkara yang mana perlu dibincangkan (tanpa hadir pihak Pengurusan di mana perlu).
- f) Untuk mengkaji program audit dalam menimbangkan keputusan hasil siasatan penting audit dalam dan tindakan pengurusan dan memastikan penyelesaian di antara Juruaudit dalam dan luar.
- g) Untuk sentiasa mengkaji keberkesanan sistem kawalan dalaman dan pertimbangan Juruaudit luar dan/atau Juruaudit dalam ke atas sistem yang dinyatakan dan khususnya mengkaji surat pengurusan Juruaudit-Juruaudit luar serta tindakbalas daripada pihak Pengurusan.
- h) Untuk mengkaji laporan-laporan audit.
- i) Untuk mengarah dan bila mana sesuai menyelia sebarang projek-projek khas atau penylasatan apabila difikirkan perlu.
- j) Untuk menimbangkan hal-hal berkenaan, sebagaimana yang dimaklumkan.

### **Prosedur Laporan**

Setiausaha akan mengedarkan minit mesyuarat Jawatankuasa Audit kepada semua ahli Lembaga Pengarah.

## TERMS OF REFERENCE

### Constitution

The Audit Committee was created by the Board of TDM Berhad pursuant to its resolution on 29 December 1994.

### Membership

The Audit Committee shall be appointed by the Board among their number and shall consist of not less than 3 members of whom a majority shall not be:-

- (a) executive directors of the company or any related corporation;
- (b) a spouse, parent, brother, sister, son or adopted son or daughter or adopted daughter of an executive director of the company or of any related corporation; or
- (c) any person having a relationship which in the opinion of the Board of Directors, would interfere with the exercise of independent judgement in carrying out the function of an audit committee.

The Chairman of the Committee shall be appointed by the Board.

If a member of the Audit Committee resigns, dies or for any other reason ceases to be a member with the result that the number of members is reduced below 3, the Board of Directors shall, within 3 months of that event, appoint such number of new members as may be required to make up the minimum number of 3 members;

### Attendance at meeting

A quorum shall be two members, one of whom shall be the Chairman of the Audit Committee. At least once a year the Audit Committee shall meet with the external auditors without any executive Board member present. The external auditor has the right to appear and be heard at any meeting of the Audit Committee.

The Company Secretary shall be the Secretary of the Audit Committee. Minutes of the meetings shall be duly entered in the books provided therefor.

### Frequency of meetings

Meetings shall be held not less than two times a year. The external auditors may request a meeting if they consider that one is necessary in particular, the Chairman of the Audit Committee shall convene a meeting of the Committee to consider any matters the external auditor believes should be brought to the attention of the Directors or Shareholders.

## *Audit Committee...cont'd.*

### **Authority**

The Audit Committee is authorised by the Board to investigate any activity within its terms of reference. It is authorised to seek any information it requires from any employee and all employees are directed to cooperate with any request made by the Audit Committee.

The Audit Committee is authorised by the Board to obtain outside legal or other independent professional advice and to secure the attendance of outsiders with relevant experience and expertise if it consider this necessary.

### **DUTIES AND FUNCTIONS**

The duties of the Audit Committee shall be:

- (a) to consider the appointment of the external auditor, the audit fee, and any questions of resignation or dismissal.
- (b) to discuss with the external auditor before the audit commences the nature and scope of the audit, and ensure co-ordination where more than one audit firm is involved.
- (c) to review with the Management and the external auditor the half – year and annual financial statements before their submission to the Board, focusing particularly on:
  - any changes in accounting policies and practices.
  - major judgemental areas.
  - significant adjustments resulting from the audit.
  - compliance with accounting standards.
  - compliance with stock exchange and legal requirements.
- (d) to arrange for periodic reports from Management, the external auditors, and the internal auditors to assess the impact of significant regulatory change; and accounting or reporting developments proposed by accounting and other bodies, or any significant matters that may have a bearing on the annual examination;
- (e) to discuss problems and reservations arising from the interim and final audits, and any matters the auditor may wish to discuss (in the absence of Management where necessary).
- (f) to review the internal audit programme, consider the major findings of internal audits and management's response, and ensure co-ordination between the internal and external auditors.
- (g) to keep under review the effectiveness of internal control systems, and the internal and/or external auditors' evaluation of the said systems and in particular review the external auditor's Management letter and management's response.
- (h) to review audit reports.
  - (i) to direct and where appropriate supervise any special projects or investigation considered necessary.
  - (j) to consider other topics, as defined.

### **Reporting Procedures**

The Secretary shall circulate the minutes of meetings of the Audit Committee to all members of the Board.

# NOTA-NOTA KEPADA AKAUN

## 1. AKTIVITI UTAMA

Aktiviti utama Syarikat adalah pegangan pelaburan dan menyediakan perkhidmatan pengurusan. Aktiviti-aktiviti utama syarikat-syarikat subsidiari dan syarikat-syarikat bersekutu adalah sepetimana tercatat di dalam Nota 4 dan 5 kepada akaun. Tiada perubahan ketara dalam aktiviti-aktiviti ini sepanjang tahun.

## 2. POLISI PERAKAUNAN YANG PENTING

### a) Asas Perakaunan

Akaun-akaun Syarikat dan Kumpulan telah disediakan mengikut kelaziman kos sejarah yang diubahsuai dengan penilaian semula aset-aset tetap tertentu dan mematuhi piawai-piawai perakaunan yang diluluskan.

### b) Asas Penyatuan

Akaun-akaun yang disatukan menggabungkan akaun-akaun Syarikat dan syarikat-syarikat subsidiari setakat akhir tahun kewangan. Baki-baki dan transaksi antara syarikat telah dihapuskan semasa penyatuan. Syarikat-syarikat subsidiari telah disatukan mengikut kaedah perakaunan pengambilalihan, kecuali Kumpulan Ladang-Ladang Trengganu Sdn. Bhd. yang telah disatukan mengikut kaedah perakaunan penggabungan menurut peruntukan Lembaga Piawai Perakaunaan Malaysia No. 11.

Keputusan syarikat-syarikat subsidiari yang disatukan atas kaedah perakaunan pengambilalihan telah dimasukkan dari tarikh pengambilalih atau sehingga ke tarikh pelupusan. Lebihan kos pelaburan dari nilai aset bersih syarikat subsidiari pada tarikh pengambilalihan diambilkira sebagai muhibah terhasil daripada penyatuan dan dilunaskan untuk tempoh selama 10 tahun.

Berkaitan dengan Kumpulan Ladang-Ladang Trengganu Sdn. Bhd. yang telah diambilkira dibawah kaedah perakaunan penggabungan, keputusan bagi tahun ini telah diambilkira sepenuhnya, tanpa mengambilkira tarikh penggabungan dan perbezaan diantara nilai nominal saham yang dikeluarkan sebagai perkiraan untuk penggabungan dan nilai nominal Modal Saham dan Premium Saham diambilkira ke dalam rizab disatukan sebagai Rizab Penggabungan.

### c) Syarikat-syarikat Bersekutu

Syarikat-syarikat bersekutu adalah syarikat di mana Kumpulan mempunyai kepentingan ekuiti jangkapanjang di antara 20% dan 50% dan membolehkan pengaruh berkesan dilaksanakan ke atas polisi kewangan dan operasi melalui perwakilan Lembaga.

Bahagian keputusan dan rizab syarikat-syarikat bersekutu yang dimiliki oleh kumpulan dimasukkan ke dalam akaun-akaun disatukan dari tarikh pengambilalihan atau sehingga ke tarikh pelupusan.

### d) Susutnilai

Tanah milik kekal tidak disusutnilai. Bagi ke semua aset tetap yang lain, susutnilai telah dikira mengikut kaedah garislurus berdasarkan anggaran jangkahayat kegunaan harta yang berkenaan mengikut kadar tahunan yang berikut:

### e) Pelaburan

Pelaburan dinyatakan pada kos. Peruntukan untuk rosotnilai ke atas nilai pelaburan akan dilakukan apabila pengarah-pengarah berpendapat bahawa rosotnilai tersebut bersifat kekal.

### f) Stok

Stok dinyatakan pada paras terendah antara kos dan nilai perolehan bersih. Kos ditentukan berdasarkan kaedah 'masuk dahulu, keluar dahulu'. Kos barang-barang siap, stok ternakan ayam dan stok semaihan meliputi kos langsung dan peruntukan kos pasti yang berpatutan. Kos stok-stok lain termasuk harga belian sebenar dicampur kos membawa barang-barang kepada kenderaan dan ke lokasi semasa bila diperlukan, peruntukan akan dibuat untuk barang-barang lapuk, tidak laku atau rosak.

### g) Penghutang

Peruntukan dibuat ke atas hutang-hutang yang difikirkan rugu kutipannya dan hapuskira dibuat ke atas hutang lapuk yang diketahui.

### h) Perbelanjaan Dibawa ke Hadapan

Perlunasan perbelanjaan permulaan dan pra-operasi dibuat dalam jangkamasa satu hingga lima tahun.

### i) Perolehan

Perolehan Syarikat merupakan yuran pengurusan dari syarikat-syarikat subsidiari, dividen dan hasil dari jualan minyak sawit mentah dan isirong. Perolehan Kumpulan termasuk yuran pemprosesan minyak sawit mentah, bonus pengurusan dari pajakan kecil, jualan selepas diskaun dari perniagaan runcit makanan dan hasil dari jualan minyak sawit mentah dan isirong, barang pertanian, pendapatan faedah daripada sewa beli dan nilai jualan atas alatan mesin dan perkakas.

**j) Pertukaran Matawang Asing**

Urusniaga di dalam matawang asing ditukar kepada Ringgit Malaysia menurut kadar pertukaran yang wujud pada tarikh urusniaga tersebut. Baki pada hujung tahun ditukar menurut kadar anggaran yang berkuatkuasa pada tarikh tersebut. Perbezaan yang timbul daripada pertukaran matawang telah dimasukkan ke dalam akaun untung rugi.

Untuk tujuan penyatuan, syarikat subsidiari asing dilapurkan dalam Ringgit Malaysia atas kadar pertukaran yang berkuatkuasa pada tarikh kunci kira-kira kecuali untuk modal saham, yang dilaporkan atas kadar pertukaran sejarah. Untung atau rugi yang timbul daripada perbezaan kadar pertukaran matawang asing dipindahkan kepada Rizab Pertukaran Matawang Asing.

**k) Cukai Tertunda**

Peruntukan disediakan menurut kaedah tanggungan berkaitan berhubung dengan semua perbezaan masa kecuali dimana kesan-kesan penundaan cukai tersebut dijangka akan berterusan pada masa depan.

**l) Perbelanjaan Penanaman Baru dan Penanaman Semula**

Perbelanjaan bagi penanaman baru iaitu pembersihan tanah dan penjagaan pokok-pokok sehingga matang dipermodalkan di bawah perbelanjaan perlادangan dan tidak dilunaskan. Perbelanjaan penanaman semula dicajkan ke dalam akaun untung rugi pada tahun di mana perbelanjaan tersebut berlaku.

**m) Aset-aset Dibawah Pajakan dan Sewabeli**

Kos aset-aset di bawah pajakan kewangan dan sewabeli dipermodalkan sebagai aset tetap dan disusutnilai berdasarkan anggaran jangkahayat kegunaan. Perbelanjaan kewangan yang berkaitan dicajkan ke dalam akaun untung dan rugi.

**n) Faedah Persaraan**

Peruntukan untuk persaraan dibuat berdasarkan nilai gaji bulan terakhir setiap pekerja yang layak dan tempoh perkhidmatan mereka, menurut terma-terma skim perkhidmatan dan dicajkan ke dalam akaun untung rugi supaya kos faedah persamaan dapat diagihkan selama jangkamasa perkhidmatan pekerja tersebut di dalam syarikat.

**o) Perbelanjaan Pembangunan**

Perbelanjaan pembangunan merangkumi perbelanjaan pembangunan tanah oleh syarikat subsidiari yang aktiviti utamanya pelaburan harta tanah.

Perbelanjaan pembangunan dinyatakan atas kos beserta keuntungan berkaitan ditolak bil kemajuan. Kos terdiri daripada kos tanah dan perbelanjaan pembangunan.

Keuntungan atas perbelanjaan pembangunan diambil kira atas kaedah peratusan siap. Apabila kerugian dikenalpasti, peruntukan penuh untuk kerugian dimasukkan ke dalam akaun.

## 1. PRINCIPAL ACTIVITIES

The principal activities of the Company are investment holding and providing management services. The principal activities of the subsidiary companies and associated companies are set out in Notes 4 and 5 to the accounts. There have been no significant changes in the nature of these activities during the financial year.

## 2. SIGNIFICANT ACCOUNTING POLICIES

### a) Basis of Accounting

The accounts of the Company and of the Group have been prepared under the historical cost convention modified to include the revaluation of certain fixed assets and in compliance with approved accounting standards.

### b) Basis of Consolidation

The consolidated accounts include the accounts of the Company and of its subsidiary companies made up to the end of the financial year. Inter-company balances and transactions have been eliminated on consolidation. The subsidiaries are consolidated on the acquisition method of accounting except for Kumpulan Ladang-Ladang Trengganu Sdn Bhd which has been consolidated on the merger method of accounting in accordance with the provisions of Malaysian Accounting Standard Board's Standard No. 11.

Subsidiaries consolidated under the acquisition method of accounting have their results included from the date of acquisition or up to the date of disposal. The excess of the cost of investments over the value of the net assets of the subsidiary companies at the date of acquisition is retained as goodwill arising on consolidation and amortized over a period of ten years.

In respect of Kumpulan Ladang-Ladang Trengganu Sdn. Bhd., which has been accounted for under the merger method of accounting, its results for the year has been accounted for in full irrespective of the date of merger and the difference between the nominal value of shares issued as consideration for the merger and its nominal value of the Share Capital and Share Premium is taken to consolidated reserve as Merger Reserve.

### c) Associated Companies

Associated companies are those in which the Group has a long term equity interest of between 20% and 50%, and exercise significant influence over the financial and operating policies through Board representation.

The Group's share of results and reserves of associated companies are included in the consolidated accounts from the date of acquisition or up to the date of disposal.

### d) Depreciation

Freehold land is not depreciated. On other fixed assets, depreciation is computed on the straight line method at the following annual rates based on the estimated useful lives of the assets concerned :

Replacements of tools and equipment are charged to profit and loss account in the year in which they are acquired.

### e) Investments

Investments are stated at cost. Provision for diminution in the value of investments is made only if the directors are of the opinion that such diminution is permanent in nature.



**f) Stocks**

Stocks are stated at the lower of cost and net realisable value. Cost is determined on a first-in, first-out basis. Cost of produce stocks, chicken farming stocks and seedling stocks comprises the direct costs and an appropriate allocation of overheads. Cost of other stocks include the original purchase price plus the cost of bringing the stocks to present condition and location. Where necessary, provision is made for obsolete, slow moving or defective stocks.

**g) Debtors**

Known bad debts are written off and provisions is made for debts considered to be doubtful of collection.

**h) Expenditure Carried Forward**

Preliminary and pre-operating expenses are written-off over a period of between one to five years.

**i) Turnover**

Turnover of the Company represents management fees from subsidiaries, dividend income and sale of crude palm oil and palm kernel. The Group turnover includes crude palm oil processing fee, management bonus from sublessees, sales less discounts from the business of food retailing, proceeds from sale of crude palm oil, palm kernel, agricultural products and building materials, interest income from finance lease and sale value of trading in machinery and equipment.

**j) Foreign Currency Translation**

Transactions in foreign currencies are translated into Ringgit Malaysia at rates ruling at transaction dates. Outstanding balances at year end are translated at the approximate rates ruling on that date. Differences arising from currency translations are included in the profit and loss account.

For consolidation purposes, the accounts of foreign subsidiaries are reported into Ringgit Malaysia at rate of exchange prevailing at the balance sheet date except for share capital, which is reported at historical rate. Gain or loss arising from exchange rate differences is transferred to Foreign Exchange Reserve.

**k) Deferred Taxation**

Provision is made using the liability method in respect of all material timing differences except where it is reasonably expected that the tax effects of such deferrals will continue in the foreseeable future.

**l) New Planting and Replanting Expenditure**

New planting expenditure incurred on land clearing and upkeep of trees to maturity is capitalized under plantation expenditure and is not amortized. Replanting expenditure is charged to the profit and loss account in the year in which the expenditure is incurred.

**m) Assets Under Lease and Hire Purchase**

The cost of assets under financial lease and hire purchase are capitalized as fixed assets and depreciated over their respective estimated useful lives. The related financial charges are charged to the profit and loss account.

**n) Retirement Benefits**

Provision for retirement benefits is made based on the last drawn monthly salary of eligible employees and the length of their service in accordance with the terms of the scheme of service, and is charged to the profit and loss account so as to spread the cost of the benefits over the employees length of service.

**o) Development Expenditure**

Development expenditure comprise of expenditure incurred on development of land by the property investment subsidiary company.

Development expenditure is stated at cost plus attributable profit less progress billings. Cost consist of cost of land and development expenditure.

Profit on development expenditure is recognized on a percentage of completion method. When losses are foreseeable, full provision for the loss is made in the accounts.

In conjunction with the acquisition of Kumpulan Ladang-Ladang Trengganu Sdn. Bhd. the Company issued 103,800,000 nominal amount 5 year 3% Irredeemable Convertible Unsecured Loan Stocks to Perbadanan Memajukan Iktisad Negeri Terengganu as settlement of the debt owing by Kumpulan Ladang-Ladang Trengganu Sdn. Bhd.

The ICULS are not redeemable and, unless previously converted, all outstanding ICULS will be mandatorily converted by the Company into new Ordinary Shares of RM1 each in the Company at the conversion price of RM4.10 on the maturity date being a date 5 years after the date of issue.

Conversion into fully paid ordinary shares of RM1 each in the Company will be allowed at any time after 1 year from the date of issue but the conversion is restricted to 25% of the total sum at the time of issue in the second, third, fourth, and fifth year.

The ICULS are constituted by a Deed of Trust dated 3 October 1997 and bear a coupon rate of 3% per annum which is payable annually in arrears.

## 24. 6-7% TRANSFERABLE CONVERTIBLE UNSECURED LOAN STOCK (TCULS)

The TCULS are transferable convertible into fully paid ordinary shares of one of the subsidiary company, Kelana Jaya Medical Centre Sdn. Bhd. during the period of five years from the date of issuance of the Convertible Loan Stock Certificate at the rate RM1.00 nominal value of TCULS for one fully paid ordinary shares of RM1.00 each in the subsidiary company.

Upon conversion of the TCULS into new ordinary shares, such shares shall rank pari passu in all respect with the ordinary shares of the subsidiary company that they shall not be entitled to any dividend or other distributions declared in respect of a financial period prior to the financial period on which the TCULS are converted.

The TCULS remaining outstanding on the maturity date will be converted by the subsidiary company on the date of one hundred percent (100%) of its nominal value. The maturity date is the expiry of a period of five years commencing on the date of issue thereof.

The TCULS bear interest of 6% per annum on the principal amount due for the period of 2 years from the issuance of Loan Stock Certificates and 7% per annum for the following period of 3 years until the maturity date.
