



EXEMPTION IN RESPECT OF PURCHASE OF RUBBER FOR CERTAIN PURPOSES.

[Gaz. Not. No. 6811/28.*

- THE Chief Secretary has granted an exemption from the provisions of section 5 (i) of the Enactment, and of rules made under the Enactment in respect of the purchase
 - (a) by a private person, of rubber in reasonable quantities for the legitimate domestic use of himself and his family;
 - (b) by a bootmaker or vendor of bootsoles, of crepe rubber built up in layers in the form known as shoe sole crepe in reasonable quantities for the purpose of making up into boots or shoes for sale in the Federated Malay States;
 - (c) Rescinded.

EXEMPTIONS FROM OPERATION OF SECTIONS 22, 25, 26 AND 27 (iv).

[Gaz. Not. No. 6256/31.*

THE Chief Secretary has granted:

- (a) to every holder of a licence under section 12, the prescribed licence fee for which is less than \$100, exemption from the operations of section 22 of the Enactment;
- (b) to all persons exemption from the operation of sections 25 and 26 of the Enactment and of section 27 (iv) of the Enactment in so far as it relates to production of the certificate for endorsement of a sale of rubber.

These exemptions may be revoked at any time by the order of the Chief Secretary.
