He informed that the AGM report has been uploaded on ENSEARCH website for members' reference and to refer to his opening address on Page 2.

2.0 CONFIRMATION OF MINUTES OF THE 33rd ANNUAL GENERAL MEETING HELD ON 18th MAY 2017.

2.1 The meeting was called to order at 4.30pm and quorum for the AGM to proceed was established.

2.2 The Hon General Secretary tabled the 33rd AGM Minutes of Meeting from Pages 5 to 11.

2.9 Datuk Ir Othman Bin Abdul Rahim proposed to adopt the Minutes of the 33rd Annual General Meeting. The motion was seconded by Ir Lee Heng Keng.

3.0 Matters Arising

3.1 The Hon General Secretary informed members that Dr Loo Koi Siang, who has been ENSEARCH's Internal Auditor, has passed away and will look for replacement.

4.0 Tabling of the 34rd Annual Report 2017/2018

4.1 Tabling of Standing Committee Report

4.1.1 The Hon. General Secretary thanked all Council members present for their continuous support.

4.1.2 The Hon. General Secretary presented the Annual Report for 2017/2018.

4.1.3 The Hon. General Secretary presented the reports from the ENSEARCH Standing Committees (Pages 12 to 28 of the Annual Report) as follows:-

- 4.1.4 The Hon. General Secretary introduced the Secretariat Staffs.
- 4.1.5 The Hon. General Secretary also announced that ENSEARCH Website has been fully revamped and is very much user friendly. Members are welcomed to contribute articles thru Berita ENSEARCH which will be uploaded on quarterly basis.
- 4.1.6 The Hon. General Secretary updated members on the status of the CPCN Project which was chaired by En Akashah Hj Majizat who has resigned due to personal matters. Members were invited to revive CPCN Projects.
- 4.1.7 Hon. General Secretary announced that the KKEF Board chaired by Dr Foo Say Moo has successfully conducted the KKEF Memorial Public Lecture 2017 and the Internship Award Winner Mr Sathish Venkitasamy has participated in the internship program with Laxmi Cement Factory, India and his detailed Internship report has been uploaded on website.
- 4.1.8 Hon. General Secretary updated the Training Calendar for year 2017. ENSEARCH will also work actively to conduct more in-house Trainings as we have more HRDF-Certified Trainers.
- 4.1.9 Hon. General Secretary informed that the Training Room at ENSEARCH will be available for rental.
- 4.1.10 The Hon. General Secretary announced that ENSEARCH is actively represented in the 3 PMHA Committees – Organizing Committee, Steering Committee & Technical Committee
- 4.1.11 Hon. General Secretary apologized to Members for not including reports on EQC. She updated some info on EQC; The President represents ENSEARCH at EQC. The 2nd term has ended on 31st March 2018 and is now awaiting Minister’s approval for ENSEARCH’s appointment to EQC.
- 4.1.12 The President added that ENSEARCH is one of the NGO among 2 civil society organizations in EQC. Consultants and Corporate Members are encouraged to take it as a good opportunity to participate in deliberations under the EQC.

4.2 Tabling of Balance Sheet & Statement of Account for the Financial Year of 2017

- 4.2.1 The Hon. Treasurer tabled the Audited Financial Statement for the year ended 31st December 2017 for discussion.
- 4.2.2 The Hon. Treasurer explained that ENSEARCH’s Income has increased compared to year 2016 however the expenditures had also increased. The increase in revenue is due to the 13th APRSCP in October 2017 as well as from Trainings. ENSEARCH had also earned some Rental income from Tenant of ground floor.
- 4.2.3 The Hon. Treasurer updated that ENSEARCH is still managing KKEF & CPCN funds under separate books.

- 4.2.4 Dato' Ir Othman Abdul Rahim questioned why there is no Fixed Deposit Interest Income for Year 2017. And the rental income has decreased compare to year 2016.
- 4.2.5 President explained that all our Fixed Deposits were not renewed as the proceeds were required to maintain the Secretariat. The rental income was lower because there was no tenant for a few months.
- 4.2.6 Ir Lee Heng Keng questioned the details of the income earned by ENSEARCH under Representative of EPIC category.
- 4.2.7 President explained that, Cenviro appointed ENSEARCH President to the Board of EPIC. The fee paid for the time and effort was credited to ENSEARCH.

Regulatory and Cleaner Production

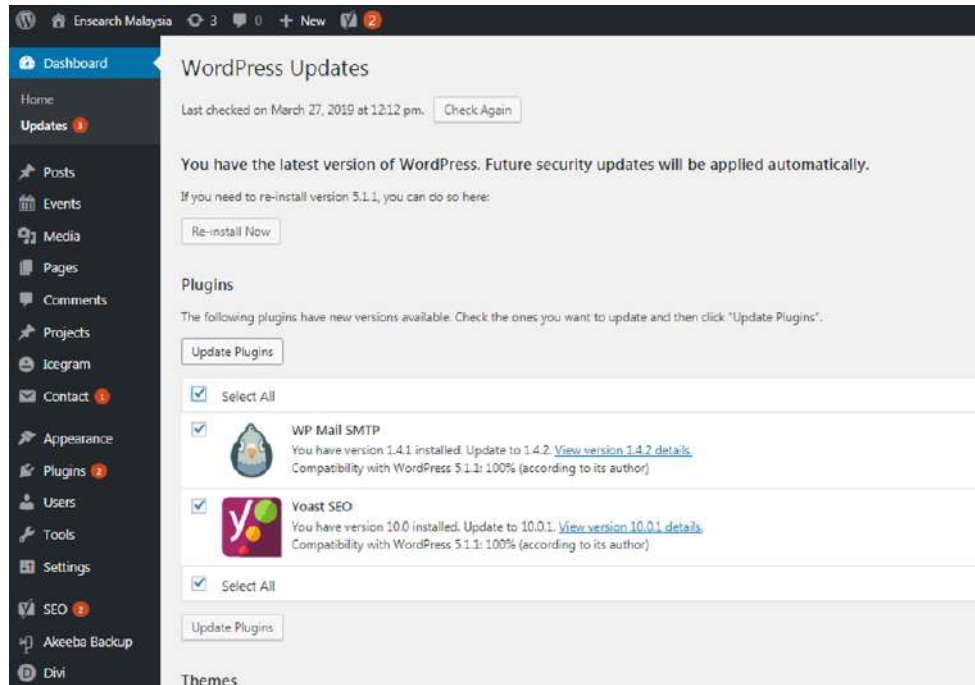

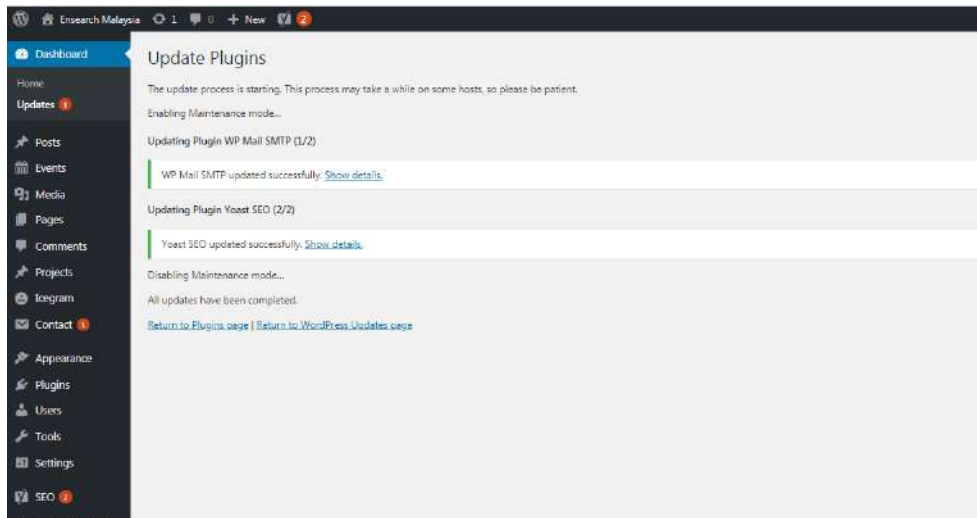

4.0 ENSEARCH AIR QUALITY TECHNICAL INTEREST GROUP (EAQTIG)

For the 2018/2019 period, the EAQTIG had successfully organised the inaugural Continuous Emission Monitoring System (CEMS) seminar entitled “Seminar on Application of CEMS as Environmental Management (EM) Tool in GSR (Guided Self-Regulations)” on 27 September 2018 at Silka Maytower Hotel, Kuala Lumpur. The group facilitator namely Mr. Tan Poh Aun attended the First Canadian Odour Conference (COC 2018) focusing on Odour Nuisance, Odour Assessment, Measurement and Control carried out on 4 and 5 December 2018 at Calgary, Canada. He had also attended the pre-conference workshops on Odour Legislation and Odour Assessment, and Agriculture Odours. For this year, the group will provide trainers for the Air Pollution Assessment for Level 1 (Beginner) and Level 2 (Intermediate) and also organize CEMS seminar towards the 2 nd half of 2019.

5.0 MALAYSIA ENVIRONMENTAL NGOs (MENGO)

ENSEARCH is a member of the Malaysian Environmental NGO network (MENGO). MENGO has been without Secretariat Staff thus, activities have been scaled down. MENGO members help out with necessary. Here are some poignant events which took place in 2018:

- May - MENGO sent a letter to the new Prime Minister requesting for more dialogue
- August - MENGO sent a letter to the Minister of Education
- October - MENGO members were invited to an initial “Engagement with NGOs on Malaysian Sustainable Palm Oil (MSPO) Standards Review” organised by the Malaysian Palm Oil Certification Council (MPOCC). ENSEARCH could not attend as the invitation to the meeting was shared with short notice compared to the previous invitation which was postponed.

6.0 ENVIRONMENTAL QUALITY COUNCIL (EQC) 2018-2020

ENSEARCH has been reappointed as an EQC member for its 3rd consecutive term commencing in May 2018 to April 2020. ENSEARCH is represented in the EQC by the President and the alternate member is the Vice President. However, for the period of May 2018 to date no meetings of the EQC has been held. ENSEARCH was an active member in the previous term of the EQC by giving constant feedbacks to issues brought up by members on all new policies, guidelines and regulations presented by the Department of Environment.

7.0 PRIME MINISTER'S HIBISCUS AWARD 2019/2020

The thirteenth cycle of the Prime Minister's Hibiscus Award, is now open for registration. The new cycle 2019/2020 was launched on 16 April 2019 by the Deputy Minister of Energy, Science, Technology, Environment and Climate Change (MESTECC) Y.B. Puan Isnaraissah Munirah Majilis.

The Hibiscus Award, which was first launched in 1996, and in 1998 received recognition from the Government and 4th Prime Minister, YAB Tun Mahathir Mohamad and henceforth known as Prime Minister's Hibiscus Award, aims to present an opportunity for public recognition of business and industry's environmental accomplishment the new cycle.

YB Puan Isnaraissah in her speech said "I am extremely pleased to see that PMHA is once again the focal point, not just for environmental performance excellence, but also serves to assist companies to meet increasingly stringent environmental requirements and global environmental challenges."

8.0 MINISTRY OF TRANSPORT/JABATAN PENGANGKUTAN JALAN (JPJ) PROJECT

The Government of Malaysia was desirous of embarking /improving/implementing on a new Policy initiative on “End-Of-Life” Vehicle culminating to a Legislation.

The Economic Planning Unit in collaboration with International Agencies designed a study some many years ago. The current President was aware of the study.

Constant engagement with Policy Officials and friends of ENSEARCH - both within and outside of the Ministry of Transport/JPJ - by our current President, resulted in ENSEARCH being requested to provide an Impact Study on the Implementation of the End-Of-Life Vehicle Policy from the perspective of Environmental Sustainability pursuant to the physical, compulsory surrender of vehicles in this category.

The Ministry of Transport/JPJ however offered ENSEARCH the sale of Special Vehicle Registration Plates in collaboration with a private Company NFORT MSC SDN BHD whose expertise was in the vehicle Registration Plates Tendering process to the general public.

ENSEARCH’s fee was agreed for RM500,000.00 from the collaboration with NFORT MSC Sdn Bhd for the effort to generate this Impact Study. Sematech Ventures Consultancy Sdn Bhd, a Company associated with our current President, was accepted to generate this Impact Study with a fee structure as cost to ENSEARCH.

This study is expected to be completed by August 2019.

2.1 Statement of compliance

The financial statements of the Association have been prepared in accordance with the basis of preparation and accounting policies as included in Note 3 to the financial statements.

2.2 Basis of measurement

The financial statements have been prepared on the historical cost basis unless otherwise stated in Note 3.

2.3 Functional currency

These financial statements are presented in Ringgit Malaysia (RM), which is the Association's functional currency.

2.4 Use of estimates and judgement

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

There are no significant areas of estimation uncertainty and critical judgements in applying accounting policies that have significant effect on the amounts recognised in the financial statements.

3. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies set out below have been applied consistently to all periods presented in these financial statements, unless otherwise stated.

3.1 Plant and equipment

(i) Recognition and measurement

Plant and equipment are stated at cost less accumulated depreciation and impairment losses.

Cost includes expenditures that are directly attributable to the acquisition of the asset. The cost of self-constructed assets includes the cost of materials and direct labour, any other costs directly attributable to bringing the asset to working condition for its intended use, and the costs of dismantling and removing the items and restoring the site on which they are located. Purchased software that is integral to the functionality of the related equipment is capitalised as part of that equipment.

When significant parts of an item of plant and equipment have different useful lives, they are accounted for as separate items (major components) of plant and equipment.

Gains and losses on disposal of an item of plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of plant and equipment and are recognised net within "other income" or "other operating expenses" respectively in the income and expenditure account.

(ii) Subsequent costs

The cost of replacing part of an item of plant and equipment is recognised in the carrying amount of the item if it is probable that the future economic benefits embodied within the part will flow to the Company and its cost can be measured reliably. The costs of the day-to-day servicing of plant and equipment are recognised in the income and expenditure account.

(iii) Depreciation

Depreciation is based on the cost of an asset less, its residual value. Significant components of individual assets are assessed and if a component has a useful life that is different from the remainder of the asset, then that component is depreciated separately.

(iii) Depreciation (Cont'd)

Depreciation is recognised in the income and expenditure account on a straight-line basis over the estimated useful lives of each part of an item of plant and equipment from the date that they are available for use.

The estimated useful lives of assets for the current and comparative periods are as follows:

Office equipments	- 25%
Furniture and fittings	- 25%
Renovation	- 25%

If there is an indication that there has been a significant change since the previous financial year end in the pattern in which the Company expects to consume an asset's future economic benefits, the Company would review its present depreciation methods and, if current expectations differ, the Company would amend the residual value, depreciation method or useful life to reflect the new pattern.

3.2 Financial instruments

3.2.1 Initial recognition and measurement

A financial asset or a financial liability is recognised in the statement of financial position when, and only when, the Company becomes a party to the contractual provisions of the instrument.

A financial instrument is recognised initially at the transaction price (including transaction costs except in the initial measurement of a financial asset or financial liability that is measured at fair value through profit or loss) unless the arrangement constitutes, in effect, a financing transaction. If the arrangement constitutes a financing transaction, the financial asset or financial liability is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

3.2.2 Subsequent measurement

Debt instruments that are classified as current assets or current liabilities are measured at the undiscounted amount of cash or other consideration expected to be paid or received unless the arrangement constitutes, in effect, a financing transaction.

Debt instruments that meet the following conditions are measured at amortised cost using the effective cost method:

- a. returns to the holder are determinable, e.g. a fixed amount and / or variable rate of return benchmark against a quoted or observable interest rate;
- b. there is no contractual provision that could result in the holder losing the principal amount or any interest attributable to the current or prior periods;
- c. prepayment option, if any, is not contingent on future events.

Investments in non-puttable ordinary shares, and investments in non-convertible and non-puttable preference shares are measured at cost less impairment, unless the shares are publicly traded, or their fair value can otherwise be measured reliably, in which case, the investments are measured at fair value with changes in fair value recognised in the income and expenditure account.

3.2.3 Derecognition

A financial liability or a part of it is derecognised when, and only when, the obligation specified in the contract is discharged or cancelled or expires. On derecognition of a financial liability, the difference between the carrying amount of the financial liability extinguished or transferred to another party and the consideration paid, including any non-cash assets transferred or liabilities assumed, is recognised in the income and expenditure account.

3.2.3 Derecognition (Cont'd)

A financial asset or part of it is derecognised when, and only when, the contractual rights to the cash flows from the financial asset expire or are settled, or control of the asset is not retained or substantially all the risks and rewards of ownership of the financial asset are transferred to another party. On derecognition of a financial asset, the difference between the carrying amount and the sum of the consideration received (including any newly created rights and obligations), is recognised in the income and expenditure account.

3.3 Cash and cash equivalents

Cash and cash equivalents consist of cash in hand, balances and deposits with banks and highly liquid investments which have an insignificant risk of changes in value. For the purpose of the statement of cash flows, cash and cash equivalents are presented net of bank overdrafts and pledged deposits, if any.

3.4 Impairment of assets

The carrying amounts of non-financial assets (i.e. plant and equipment) are reviewed at the end of each reporting period to determine whether there is any indication of impairment.

If any such indication exists, then the asset's recoverable amount is estimated. For the purpose of impairment testing, assets are grouped together into the smallest group of assets that generates cash inflows from continuing use that are largely independent of the cash inflows of other assets or groups of assets (the "cash-generating unit").

The recoverable amount of an asset or cash-generating unit is the greater of its value in use and its fair value less costs to sell. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset or cash generating unit.

3.4 Impairment of assets (Cont'd)

An impairment loss is recognised if the carrying amount of an asset or its cash-generating unit exceeds its recoverable amount.

Impairment losses are recognised in profit or loss. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the units and then to reduce the carrying amount of the other assets in the unit (groups of units) on a pro rata basis.

An impairment loss recognised in prior periods are assessed at the end of each reporting period for any indications that the loss has decreased or no longer exists. An impairment loss is reversed if there has been a change in the estimates used to determine the recoverable amount since the last impairment loss was recognised. An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised. Reversals of impairment losses are credited to profit or loss in the year in which the reversals are recognised.

3.5 Equity Instruments

Ordinary shares are classified as equity. Instruments classified as equity are measured at cost on initial recognition and are not remeasured subsequently.

3.6 Provision

A provision is recognised if, as a result of a past event, the Company has a present legal or constructive obligation that can be estimated reliably, and it is probable that an outflow of economic benefits will be required to settle the obligation.

Provisions are determined by discounting the expected future cash flows at pre-tax rate that reflects the market assessments of the time value of money and the risks specific to the liability. The unwinding of the discounting is recognised as finance cost.

3.7 Revenue

(i) Subscription income

Subscription income is recognised when the right to receive is established.

(ii) Income from activities

Income to be utilised for specific seminars and projects are recognised upon the seminars and projects being conducted.

(iii) **Other Income**

Income from other sources to be intended for general purposes are recognised upon entitlement to receive.

(iv) **Interest income**

Interest income is recognised as it accrues, using the effective interest method.

(v) **Office rental income**

Revenue from rental of office is recognised progressively over the term of the lease.

3.8 Tax expense

Income tax expense comprises current and deferred tax. Income tax expense is recognised in the income and expenditure account.

Current tax is the expected tax payable on the taxable income for the financial period, using tax rates enacted or substantially enacted by end of the reporting period, and any adjustment to tax payable in respect of previous financial years.

Deferred tax is recognised using the liability method, providing for temporary differences between the carrying amounts of assets and liabilities in the statement of financial position and their tax bases. Deferred tax is not recognised for the initial recognition of assets or liabilities in a transaction that is not a business combination and that affects neither accounting nor taxable profit or loss. Deferred tax is measured at the tax rates that are expected to be applied to the temporary differences when they reverse, based on the laws that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax assets and liabilities are offset if there is a legally enforceable right to offset current tax liabilities and assets, and they relate to income taxes levied by the same authority on the same taxable entity.

A deferred tax asset is recognised to the extent that it is probable that future taxable profits will be available against which temporary difference can be utilised. Deferred tax assets are reviewed at the end of each reporting period and are reduced to the extent that it is no longer probable that the related tax benefit will be realised.





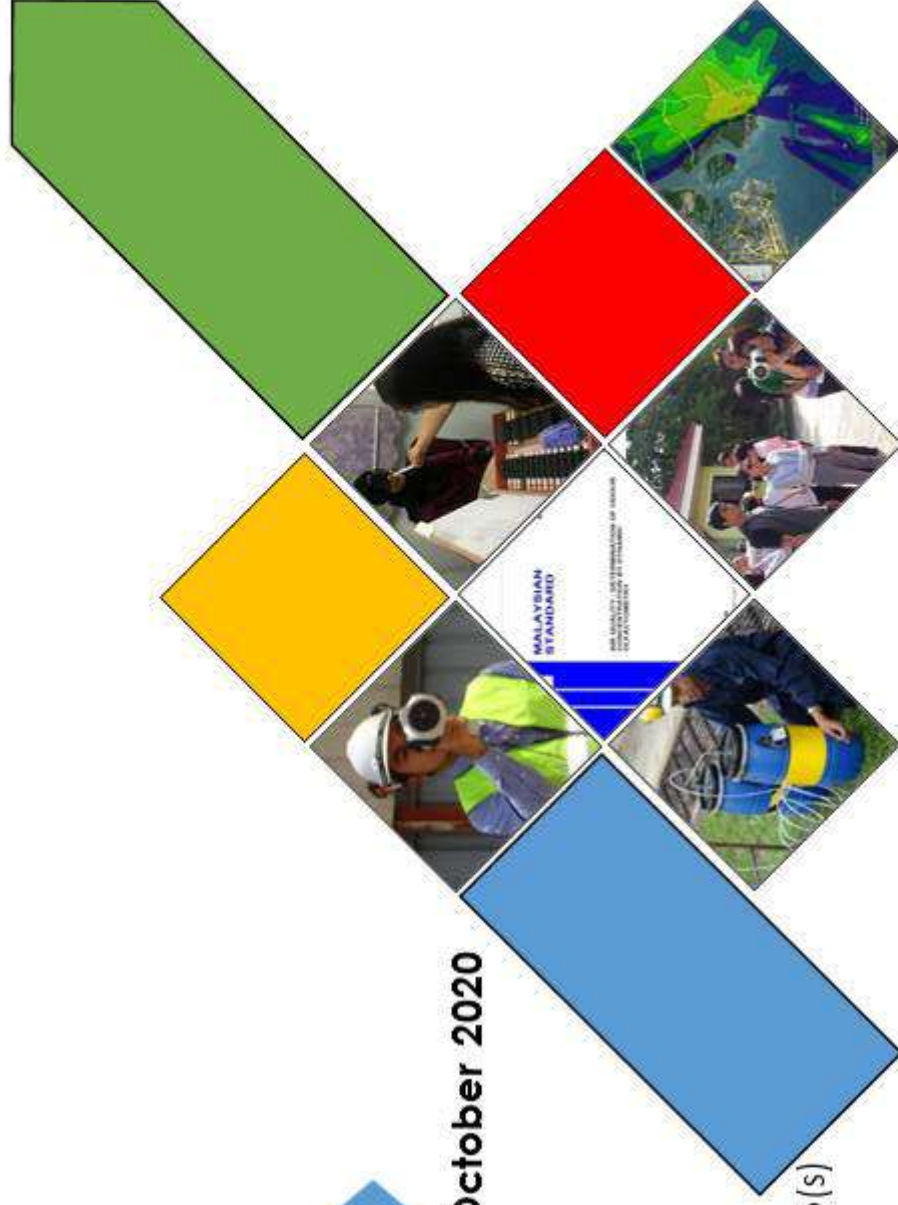
